To take our care one step further, we are also actively looking to enhance our services for senior citizens by providing long stay options, companion services and starting a city wide senior citizen club. Long stay options for senior citizens will provide fully serviced accommodation at our Bhugaon campus for stays of upto 1-2 months. Our companion service initiative will provide trustworthy, empathetic companions for senior citizens living in Pune, helping them with daily errands, doctor visits, temple outings, movies, walks, or simply meaningful conversations – services that many elders quietly long for.

- Enhance facilities and activities at Nisarg Chhaya (more cultural events, wellness sessions, accessibility features, and expanded indoor recreation options)
